Contractor is not authorized to disclose Confidential Information, make it accessible to unauthorized third parties and may not use it other than in the interests of the Client and/or his client. Contractor acknowledges that, in the interest of the protection of Confidential Information, the provisions of the applicable legislation are compulsory for him under this confidentiality provision.

7. Other provisions:

- 7.1. In matters not covered by this contract, the regulations of Hungarian law (Ptk.) are applicable.
- 7.2. In the event of dispute, the Parties are obliged to hold a conciliation hearing and may only turn to court after their failure.
